# POLYHEDRAL ROLEPLAYING SYSTEM

## LICENSING INFORMATION

If you're interested in licensing *The Polyhedral Roleplaying System* to produce your own works, there are three different licenses to choose from for each work you wish to release. Each individual work must be released with one of these licenses attached to it.; you may use multiple licenses for multiple works, but each work must only have one license attached to it.

The Three Polyhedral Roleplaying System Licenses

The **CREATOR License** allows creating free and non-commercial content. They may only reference other existing works and cannot constitute a "full game" or "complete game". There is no fee to use this license, nor do you need approval to publish works.

The **PUBLISHER License** allows creating works and selling them commercially. Works created under this license can reference other existing works and reproduce a percentage of authorized content, but cannot constitute a "full game" or "complete game". There is no fee to use this license, but all prospective licensees must submit their product for approval before releasing it commercially.

The **PARTNER License** allows creating works of any type and selling them commercially. Full complete standalone game products may be produced that do not require another *Polyhedral Roleplaying System* product to provide the core rules for play, Other works can be referenced and a percentage of other works can be reproduced. There is a fee to use this license, and approval to publish works is required before it is made commercially available to align the work with the *Polyhedral Roleplaying System* ecology.

All three licenses allow creators to sublicense their works (if they choose) for use by others who agree to terms of one or more of the licenses, as well as to allow referencing them.

"Commercial" is defined as making money from selling a work to others to make a profit.

A "full game" or "complete game" is defined as a standalone product that can be used without requiring another *Polyhedral Roleplaying System* product to provide the core rules for play.


